Four (4) rental guest key tags will be provided to the rental company of record/private rental home owner for rental guest use. Y-Home rental home owners will receive owner key tags for each owner listed intended as a courtesy for use at the Outer Banks Family YMCA while staying in the rental property when it is not rented. **Owner key tags must be used for check in, but are not intended to be used in place of a YMCA of South Hampton Roads Individual or Family membership which must be purchased separately or for use by owners who also reside in the Outer Banks and wish to use the YMCA year round.**

The Outer Banks Family YMCA reserves the right to revoke contract privileges at any time with or without notice to ensure the safety and comfort of YMCA members and to prevent abuse of the Y-Amenity program that would cause the YMCA financial hardship. In the event that the YMCA terminates an agreement prior to the contract term, then the YMCA would refund the unused portion of the Y-Home package that was purchased.

Y-Home Annual Membership Contracts are processed upon receipt of contract and payment in full. Membership runs from date of purchase through annual anniversary date. ***Please allow 7-10 business days for processing.*** New guest cards will be furnished at no charge upon contract renewal; during active membership year, a \$10/guest card replacement fee will be assessed and cards will be reissued upon receipt of payment by rental company/private rental home owner. Please request and complete Y-Home Key Tag verification form to begin process.

Y-Home Membership Rates Based upon number of bedrooms. Rental home occupancy is the maximum number of guests admitted at any time to utilize/receive admittance to the facility. Occupancy for rate renewal will be verified by the rental company catalog, website and management company. **To obtain YMCA of SHR Member Rates, owner must remain a YMCA of SHR member during the term/duration of the Y-Home agreement.**
